



Competition terms and conditions

International category

1. The International category forms part of the Childnet Film Competition 2022, organised by Childnet International. Whilst in line with the UK competition, the International category operates as a separate competition.
2. To avoid confusion between the International category and the UK categories, the launch and closure dates for the International category of the Childnet Film Competition are different from the UK competition.
3. The International category is for young people aged between 7–18 who attend schools outside of the UK. Entrants must select to enter either, the age group, 7–11 (in the UK, primary school age) or the age group, 11–18, (in the UK, secondary school age).
4. All films entered into the International category of the Childnet Film Competition must be in the English language.
5. One winning film will be selected from the primary and secondary age groups of the International category of the Childnet Film Competition. These will be featured on the Childnet website and the UK Safer Internet Centre website.
6. Educators must sign the entry form on behalf of entrants. Only films entered with the signed entry form will be considered for the competition. The named adult on the entry form will be the main point of contact.
7. All films must be returned with both the completed media consent and signed entry forms by 5pm on Wednesday 22nd June 2022. Films received after this date cannot be considered for the competition but may still be featured on the Childnet website and the UK Safer Internet Centre website. 8. Entrants and film groups can be between 1–8 people. This must include those who do not appear on camera but are working behind the scenes (for example, a camera operator or director).
9. Schools can enter more than one film but only one film per individual or film group.
10. All films must be no longer than 2 minutes. This time frame must include title sequences and credits should you decide to use these. If adding credits, keep them brief to avoid cutting into your film time.
11. In the interests of child protection, credits added to the end of any film should contain first names only, in accordance with Childnet's media consent policy. Any films that contain full names of children in the credits cannot be considered for the competition. For more information on how we handle data, please refer to Childnet's privacy policy.
12. All films must reflect the theme of the category.
13. All films must feature a positive message and contain appropriate content and imagery.
14. The emphasis of the competition is on the message rather than a professional standard of recording. However, we ask that film entries are of a high enough standard comparable to other resources that would be used to educate young people.

15. To maximise the learning element of the project, we encourage that all filming and production should be the work of the young person/people taking part. Adult involvement should be limited to supervision and technical support, NOT content writing or creation.

16. All films must respect copyright law. We prefer original music and video content. If you wish to use others' copyrighted material (for example, music, imagery or footage) you must obtain written permission from the copyright holder prior to the submission of your film and include this information with your entry. We cannot obtain this permission for you. Films submitted without a copyright holder's permission cannot be selected for shortlisting.

17. To ensure content and copyright terms are adhered to before entering the International category of the Childnet Film Competition, all films must be overseen by the named adult on the entry form.

19. Only the winning films from each age group will receive a prize. Childnet reserves the right to change the prizes from those stated on the International Category page of the Childnet website. Due to logistical issues in despatching physical goods, we will provide vouchers or transfer the prize money to obtain those prizes. **Please note:** The prize is intended to support future content creation for the winners, so by taking part in the competition, you are agreeing that the prize money will go directly to the school and not to any named individuals. The school bank account must be one that can receive payments from overseas (eg, not a deposit account).

20. The winning film from the primary and secondary age groups will be announced on the Childnet website on 27th July 2022.
